**Notification about the processing of your personal data:** In accordance with the demands of the EU's General Data Protection Regulation 679/2016 (GDPR), as well as with the law 4624/2019, Gnosis Assessment Hellas would like to request your consent to the collection and processing of your personal data, which you voluntarily accept to provide for the purposes of the administration of the TIE examinations, as well as of any other information, printed or electronic, you apprise us with in the future. **Access to Personal Data:** Access to the above data is granted to Gnosis Assessment Hellas staff and partners and to Gatehouse Awards, which is the awarding body responsible for the issue of the TIE certificates.

**Impartation of Personal Data:** Gnosis Assessment Hellas will NOT impart, retrocede, sell or dispose your personal data to a third party with any other means, with or without an exchange, before getting your full consent.

**Time period for personal data processing:** Gnosis Assessment Hellas collects, saves and processes your personal data as follows: a. the data requested from the tax legislature for as long as it is defined by the relevant in effect legislature, b. the Candidate's personal data which are necessary for the administration and completion of the examination for as long as it is defined by the relevant legislative, regulative and administrative provisions.

**Your rights:** You have the right to revoke your consent partly or in total at any time you choose. The revocation of your consent will not affect the legitimacy of the processing for the time that we had your consent. The above revocation will not affect those data that are defined as necessary by the relevant tax or other legislature for as long as it is expected. In addition, you are entitled to all the rights which are defined by the Regulation. More specifically, you have the right to: a) be given access to your personal data that are kept, processed and disposed by Gnosis Assessment Hellas, b) request that your personal data are updated, c) request from Gnosis Assessment Hellas to delete your personal data from its records when their processing is not considered necessary for the purposes for which they were initially collected, d) request that the use of your personal data is restricted in accordance with the article 18 of the Regulation and e) receive the data that you have provided.
